

CONGRESS TERMS AND CONDITIONS

1. DEFINITIONS

1.1 In the Agreement the following words and phrases have the following meanings:

Agreement: the Congress Terms and the Registration Form;

Applicant: the party named as such on the Registration Form;

Applicant Credit Card: the credit card specified by the Applicant on the Registration Form;

Cancellation Notice: has the meaning given in clause 3.5;

Categories of Countries:

Congress: 15th WFSA World Congress of Anaesthesiologists®, taking place between 25-30 March 2012 in Buenos Aires, Argentina;

Congress Dates: 25 – 30 March 2012;

Congress Package: available to Applicants for full delegate registrations and for resident/trainee registrations and includes: participation in all scientific sessions except workshops; delegate bag containing all printed Congress materials; participation at the opening ceremony; participation in the closing ceremony;

Congress Rate: the appropriate registration fee payable (inclusive of any applicable sales tax) on submission of the Applicant's Registration Form (and the Eligibility Document, if applicable), as follows:

Accompanying Person registration rate*** US \$200

***The Accompanying Person registration rate includes participation in the Opening Ceremony, including the Welcome Reception, participation in the Closing Ceremony, and one half day city tour starting 1400 hrs, ending 1700 hrs.

Congress Terms: these terms and conditions;

Congress Venue: La Rural, Juncal 4431, C1425BAA, Ciudad Autonoma de Buenos Aires, Argentina;

Congress Website: www.wca2012.com;

Delegate: the Applicant;

Eligibility Document: an official letter on letter-headed paper issued by the Head of Department in which the Applicant is working, confirming the Applicant's entitlement to the appropriate reduced Congress Rate;

Registrar/Trainee Registration: reduced registration fees available only to Registrars/Trainees on receipt of the Eligibility Document;

Registration Fee: the Congress Rate;

Registration Form: the WCA 2012 registration form entitled as such on Choice Live's website relating to the Congress;

Workshops: hands-on sessions for which an additional fee per workshop is payable, as advertised on the Congress website.

1.2 In the Agreement:

1.2.1 the singular includes the plural and vice versa;

1.2.2 references to gender include references to all genders;

1.2.3 unless otherwise stated, references to clauses are to clauses of the Agreement;

1.2.4 the clause headings are for reference only and will not affect the construction or interpretation of the Agreement; and

1.2.5 references to statutes, any statutory instrument, regulation or order will be construed as a reference to such statute, statutory instrument, regulation or order as amended or re-enacted from time to time.

1.3 In the event of conflict, the Congress Terms will prevail over the Registration Form.

2. APPLICATION OF TERMS

- 2.1 The Registration Form submitted by the Applicant on the Congress Website will be deemed to be an offer by the Applicant for the Delegate to attend the Congress subject to the terms and conditions of these Congress Terms. The Applicant's offer will be accepted upon Choice Live sending written notification to the Applicant confirming that the Applicant's Registration Form has been accepted.
- 2.2 No terms or conditions endorsed on, delivered with or contained in the Applicant's purchase order, confirmation of order or other document will form part of the Agreement simply as a result of the document being referred to in the Agreement.

3. CONGRESS

- 3.1 Choice Live will hold the Congress at the Congress Venue on the Congress Dates.
- 3.2 The parties acknowledge that a number of registration fees are available to prospective delegates for attendance at the Congress.
- 3.3 The Delegate may benefit from the Resident/Trainee Registration if the following conditions are satisfied:
- (i) the Delegate is a resident or a trainee at the time of WCA 2012; and
 - (ii) the Eligibility Document is submitted within 5 days of registering for the WCA 2012.
- 3.4 Upon payment of the Registration Fee, Choice Live will send the Applicant written notice confirming that the Applicant's Registration Form has been accepted (in accordance with clause 2.1), and Choice Live will then reserve a place for the Delegate to attend the Congress on the terms of the relevant registration specified on the Applicant's Registration Form. This is subject to Choice Live receiving satisfactory Eligibility Documents (as determined by Choice Live in its sole opinion), if applicable, as referred to in clause 1.1. In case of failure to send the relevant document to Choice Live within 5 days of payment of registration fee, the relevant registration will be cancelled and any monies paid, minus US \$30 administration fee, will be refunded.
- 3.5 The Applicant may cancel his registration and the Accompanying Person Registration by sending written notice of such cancellation ("**Cancellation Notice**") to the Choice Live Cancellation Team.
- 3.6 In the event that Choice Live receives the Applicant's Cancellation Notice
- 3.6.1 for a full delegate registration or a registrar/trainee registration or an Accompanying Person registration:
- (i) on or before 30 November 2011, Choice Live will refund the Applicant with the Registration Fee less an US \$80.00 administrative fee;
 - (ii) after 30 November 2011, no refund will be payable to the Applicant;
 - (iii) a name change will be permitted on or before 31 January 2012, on payment of an US \$80.00 administrative fee;

(iv) no name changes will be permitted after 31 January 2012.

3.6.2 for a nurse registration at any time, no refund will be payable to the Applicant and no name changes will be permitted.

3.7 Workshops are non-refundable and non-transferable/non-changeable at any time.

3.8 All refunds will be credited in US \$ to the credit card used by the applicant for payment. The rate of exchange for accounts not held in US\$ will be that set by the applicant's credit card company. Choice Live cannot accept liability for any losses due to the exchange rate applied.

3.8 The parties acknowledge that each delegate contract relating to the Congress is deemed to be separate and independent to other delegate contracts (including the Agreement) and that any variation and/ or waiver to a third party delegate contract will not affect the parties' rights and obligations under the Agreement unless such variation and/ or waiver is made in accordance with the terms of the Agreement.

4.0 The Applicant will immediately notify Choice Live in writing of any changes to the information submitted by the Applicant on the Registration Form.

4. PRICE AND PAYMENT

4.1 In consideration of Choice Live providing the Delegate with the opportunity to attend the Congress, the Applicant will pay Choice Live the Registration Fee.

4.2 The Applicant will submit payment of the Registration Fee with his Registration Form.

4.3 The Applicant hereby irrevocably authorises Choice Live to charge the Registration Fee to the Applicant Credit Card in accordance with clause 4.2.

4.4 The Applicant warrants to Choice Live that it is authorised to charge the applicant a fee of US \$30 for any bank transfer payments.

5. WARRANTIES AND LIABILITY

5.1 The Applicant warrants to Choice Live that the information stipulated by the Applicant on the Registration Form and any updated information submitted to Choice Live in accordance with clause 3.9 is true, complete and accurate.

5.2 The Applicant warrants to Choice Live that it is authorised to provide Choice Live with the Applicant Credit Card for payment of the Registration Fee.

5.3 Save as expressly specified in the Agreement, all terms, conditions, warranties, representations, or guarantees, whether express or implied, relating to the performance, quality or fitness for purpose of any part of the goods and/or services provided by Choice Live under the Agreement are, to the fullest extent permitted by law, hereby excluded.

- 5.4 Neither party excludes or limits liability to the other party for death or personal injury caused by that party's negligence, or liability for fraudulent misrepresentation, or any breach of any obligations implied by Section 12 of the Sale of Goods Act 1979 or Section 2 of the Supply of Goods and Services Act 1982.
- 5.5 Subject to clauses 5.4 and 5.6, the entire financial liability of Choice Live in respect of all or any breaches of the Agreement or of any other duty to the Applicant or for negligence in connection with the subject matter of the Agreement will be limited to the amount of the Registration Fee.
- 5.6 Subject to clause 5.4, in no event will Choice Live be liable to the Applicant for any of the following however and whenever arising:
- 5.6.1 loss of profits; or
 - 5.6.2 loss of business; or
 - 5.6.3 loss of revenue; or
 - 5.6.4 loss of data; or
 - 5.6.5 loss of goodwill; or
 - 5.6.6 loss of anticipated savings; or
 - 5.6.7 any special, indirect, consequential or pure economic loss, damage, costs or expense.
- 5.7 The Applicant will indemnify Choice Live forthwith upon demand in respect of any loss, damage, cost or expense suffered or incurred by Choice Live as a result of the Applicant breaching any of its obligations in the Agreement.

6. TERMINATION

- 6.1 Notwithstanding any other provision of the Agreement, and without prejudice to any other rights that Choice Live may have, Choice Live may forthwith terminate the Agreement by written notice to the Applicant if any of the following events occur:
- 6.1.1 if the Applicant is in material breach of a provision of the Agreement and fails to remedy such breach (if capable of remedy) within 14 days of having received written notice of breach; or
 - 6.1.2 if the Applicant (being an individual) has a statutory demand or bankruptcy order made against him or makes an arrangement or composition with creditors or otherwise takes the benefit of any statutory provision for the time being in force for the relief of insolvent debtors, or (being a body corporate) enters into administration (whether out of court or otherwise), receivership, liquidation, a formal arrangement with its creditors or any analogous proceedings or procedure, or is otherwise insolvent or ceases or threatens to cease to trade.
- 6.2 Termination of the Agreement will be without prejudice to any accrued rights or obligations of either party.

7. FORCE MAJEURE

- 7.1 Neither party will be liable for any failure or delay in the performance of the Agreement which is caused by circumstances beyond the reasonable control of the party concerned including, without limitation, acts of God, war or national emergency, acts of terrorism, strike, lock-out, fire, explosion, volcanic eruption, and flood (**"Force Majeure"**), provided always that the defaulting party uses all reasonable endeavours

(but without an obligation to incur cost) to minimise the period of disruption caused by Force Majeure.

- 7.2 Choice Live reserves the right to defer or to cancel the Congress (without liability to the Applicant) in the event of a Force Majeure.

8. DATA PROTECTION

- 8.1 Choice Live will process personal information ("**Information**") as defined in the Data Protection Act 1998 ("**DPA**") provided by the Applicant to Choice Live in accordance with applicable data protection law and this clause 8. The Applicant consents to Choice Live using Information as follows:

8.1.1 Choice Live will obtain, record, store and use Information as necessary in connection with the Congress including transfer of Information to employees, agents and third parties as required for this purpose;

8.1.2 Choice Live may transfer its business assets (which includes Information) on re-organisation, sale or merger of the whole or any part of its business;

8.1.3 Choice Live reserves the right to process Information as required for marketing purposes, to obtain legal advice, comply with legal requirements, enforce or apply any agreements (including the Agreement) and protect the rights, property or safety of Choice Live, its employees, its clients and others; and

8.1.4 Choice Live may transfer Information outside the European Economic Area for any of the purposes listed in this clause 8.

- 8.2 If Choice Live intends to process Information other than as set out above the Applicant will receive notice and be given the opportunity to decline the processing.

9. GENERAL

- 9.1 The Agreement contains the whole agreement between the parties in respect of its subject matter and supersedes any prior written or oral agreement between them, and the parties confirm that they have not entered into the Agreement on the basis of any representations that are not expressly incorporated in the Agreement. Nothing in the Agreement will operate to limit or exclude any liability for fraud.

- 9.2 No amendment to the Agreement will be binding unless made in writing and signed by an authorised signatory of each party.

- 9.3 The Applicant will not assign, charge or otherwise transfer to a third party any of its rights or obligations hereunder without the prior written consent of Choice Live. Choice Live may assign, transfer or sub-contract any of its rights or obligations hereunder without the prior written consent of the Applicant.

- 9.4 No waiver of any breach of either party's obligations hereunder will represent a waiver of the waiving party's rights hereunder or of any subsequent breach.

- 9.5 The parties respectively will and will procure that any other necessary party will execute all such documents and do all acts and things as may reasonably be required to secure each of the obligations of the parties under the Agreement.
- 9.6 None of the provisions of the Agreement are intended to or will operate to confer any benefit pursuant to the Contracts (Rights of Third Parties) Act 1999 on a person who is not named as a party to the Agreement.
- 9.7 Any notice to effect cancellation, suspension or termination of the whole or any part of the Agreement:
- 9.7.1 will be made in writing and either delivered personally or sent by recorded delivery or via electronic mail, to the party to whom the notice is addressed at its address as set out in the Agreement or such other address as a party may specify by notice in writing to the other party;
- 9.7.2 in the absence of evidence of earlier receipt, receipt will be deemed to have been duly given:
- (i) if delivered personally, when left at the address referred to in clause 9.7.1; or
 - (ii) if sent by recorded delivery, at the time recorded by the delivery agent ;or
 - (iii) if sent by electronic mail, at the time of receipt (for the avoidance of doubt all electronic mail should be sent with a read receipt notification request).
- 9.8 For the avoidance of doubt electronic mail will be deemed to be “writing” for the purpose of the Agreement but this will not prejudice the express requirements for delivery of notices under clause 9.7.
- 9.9 If any provision of the Agreement is held to be void or unenforceable in whole or in part, the Agreement will continue to be valid as to the other provisions thereof and the remainder of the affected provision.
- 9.10 The Agreement will be binding on and will continue for the benefit of the permitted successors and permitted assigns (as the case may be) of each of the parties.
- 9.11 All provisions of the Agreement will, so far as they are capable of being performed and observed, continue in full force and effect notwithstanding any expiry or earlier termination.
- 9.12 Nothing in the Agreement is intended to, or shall be deemed to, constitute a contract of employment.

10. DISPUTE RESOLUTION PROCEDURE

If any dispute arises in connection with the Agreement, a representative of each party with authority to settle the dispute will, within 21 days of a written request from one party to the other, respond in writing in an effort to resolve the dispute. If the dispute is not resolved within said correspondence, either party may commence legal proceedings.

11. APPLICABLE LAW

The Agreement will be governed by and construed in accordance with the laws of England and Wales and, subject only to clause 10, the parties submit to the exclusive jurisdiction of the English courts for the resolution of any dispute.
