- 3) If the equipment was lost or damaged by the Customer, it shall give notice immediately AZULADO SA, who will replace or repair at the expense of the Customer. The amounts payable by the latter include the replacement or repair costs, administrative fees and transportation, etc. These sums shall be paid by the Customer when picking the team.
- 4) AZULADO SA shall not be liable and held harmless by the harmful consequences, or losses, direct and indirect, incurred by the customer or third party, arising or resulting from the use of equipment.
- 5) In case of default, the party has fulfilled its obligations may elect to terminate this Agreement or demand and / or enforce compliance without any intimation. In both cases the defaulting party shall indemnify the damages (Art. 1204 3rd paragraph C. Civ.). In the event of termination of the Agreement because of Client AZULADO SA immediately remove the equipment, placing them under his guardianship, and retain the sums paid, subject to the greatest damage that the Customer must pay compensation.
